



Water Fill Station (WFS) User Terms and Conditions

- The WFS operated by La Plata West Water Authority is located at 555 County Road 122, Hesperus, Colorado.
- This station provides bulk water sales that are limited to the public, commercial users, and contractors within a predetermined area within LPWWA's service area.
- A standard 2" quick connect connection is installed on the fill station, customers will need to adapt to this connection. The discharge from the station is anticipated to be approximately 80 gallons per minute (GPM).
- Provided there are available funds in your account, the fill station will be open for use 7 days a week.
- Hours of operation: 6:00 AM to 9:00 PM or otherwise posted for consumption control. Operating hours may be subject to change.

Account Setup

- Customers will be required to setup a prepaid account with La Plata West Water Authority prior to use. Proof of property ownership within our service area will be required.
- To open an account, customers must complete a LPWWA Water Fill Station Application and submit it to LPWWA office at address above. Be prepared to provide personal or company information and vehicle(s) information, license plate numbers, and tank capacity in gallons.
- Applications are available at the LPWWA Office, 555 County Road 122.
- A fact sheet is available, or a 1:1 training may be available

All customers will access the station with key code that will be provided to the customer once their account is set up.

Customers must pre-pay accounts before fill up by paying with cash, check, or credit card at the office. Only checks payable to La Plata West Water Authority may be mailed to: 555 County Road 122, Hesperus, CO. Please allow 48 hours for check processing. Once your account is set-up, you can choose to pay online at LPWWA.ORG.

Rates and Fees

All bulk water use by customers shall be metered and paid for under rates and fees established by LPWWA. Rates may change at any time.

Customers using the bulk water fill station shall pay the following:

A onetime administrative fee of \$10.00

Residential & Commercial: \$0.025 per gallon drawn.

Terms and Conditions

Bulk water fill station residential and commercial users are required to comply with all policies when using LPWWA owned municipal bulk water fill station. Non-compliance with the policies of the application and fill station may result in revocation of an account and fill station approval and/or denial of future access. Bulk haulers may not distribute water to the Lake Durango Water Authority's service area.

1. Complete and sign a LPWWA Bulk Water Fill Station Application. Applications are to be turned in to the LPWWA for account setup.
2. The La Plata West Water Authority (hereafter called the Authority) will use all reasonable actions to supply the quantity of water required by the customer, by making it available for collection at the fill station.
3. An approved customer shall be issued with an account number and PIN for the vehicles named in its application, which will enable the customer to access the Authority's fill station. The Authority reserves the right to discontinue an account and a customer from bulk water purchasing at any time. (Limitations of your residence may apply)
4. Accounts may only be used by the account holders and vehicles which are listed on the application.
5. Having an account does not guarantee access to fill, as the Authority does not warrant or represent it will guarantee a continuous supply of water in the quantity required by the customer. The Authority may at its discretion reduce, interrupt, or discontinue the supply of water to the customer at any time. Additional circumstances may occur where a balance is too low, drought management reductions, mechanical problem, or other closure, may limit your ability to get water.
6. The Authority may suspend or terminate access to the fill station if the operation is determined to compromise and/or adversely impact the Authority's water system sources, operations, facilities, and/or direct water service obligations.
7. The Authority is not responsible for accidents or damage due to use of the fill station.
8. The Authority accepts no responsibility for any of the water that the customer may take beyond the fill station.
9. The customer shall comply with state, federal, and local government regulations.
10. The customer shall retain good hygiene and sanitary practices while at the fill station. The customer shall also use trash containers. No trash or cigarette butts shall be thrown on the ground.
11. The customer shall avoid spillage, leakage, run-off, or ponding from the tank, tanker, or the fill station.
12. Any tank or tanker shall be configured to prevent spillage or leakage while stationary or in transit and be maintained in good order.

14. Please report vandalism, graffiti, skateboarding, or other illegal activities to the La Plata County Sheriff's Dispatch, non-emergency at (970) 385-2900.

15. Damages or loss to the fill station or the theft of water will be billed to the customer.

16. Water withdrawn from the Authority's system without prior authorization is a criminal act and punishable under Federal and State Laws. Unlawful tampering with waterworks results in a Class 6 Felony, which carries a maximum penalty of five years in jail.

17. In exchange for permission to operate and obtain water from the Authority's bulk water fill station, the Applicant/Customer agrees to defend, indemnify, and hold harmless the Authority and its officers, directors, employees, and agents from and against all claims, costs, losses, and damages, including, but not limited to attorney and other professional fees arising out of, connected with, or resulting from, the connection to the bulk water fill station, and the use of the water therefrom covered by this authorization.

Residents within the Authority's service area within 400 feet of existing service lines (As per La Plata County Land Use Code Sec. 70-4.III.B.1. General Requirement) either now or with future line extensions will have limited time to be qualified to use the WFS. Check the box that you've read and understand this limit. This limit has yet to be determined.
